



LMHI ACCREDITATION REGULATIONS

1. Homeopathic teaching programs eligible for accreditation may be provided by the following institutions:
 - (a) independent individual teaching centers,
 - (b) national federations of teaching centers, or
 - (c) homeopathic doctors' associations providing education and training.
2. Only those institutions that are members of the LMHI may qualify for accreditation of their teaching program. With the exception of the (a) independent teaching centers with less than 15 members, that cannot be Institutional LMHI members. They will apply after the payment of the LMHI fees as individual members, or through a national association institutional member of the LMHI.
3. Institutions that apply for accreditation of their teaching program should submit their training program in English to the LMHI. The training program should comply with the requirements as laid down in the LMHI Medical Homeopathic Education Standards and should include the complete training program and the examination procedures of the teaching center.

ACCREDITATION PROCEDURES

- a) In order to begin with the accreditation process, the applicant should contact the LMHI Secretariat (lmhi.assistant@gmail.com), who will confirm its membership status and send the LMHI Accreditation Form. This should be completed by the applicant and sent back to the LMHI Secretariat and to the LMHI Secretary for Education.
- b) Once the Secretary for Education has received the complete training program and necessary requirements, he/she will start the accreditation process by reviewing the application of the national association or teaching center. If the documents are complete and reliable, on first review, the Secretary for Education will present the application to the LMHI Executive Committee.

If the documents are complete and reliable, on first review, the Secretary for Education will present the application to the LMHI Executive Committee.

- c) The application will be discussed and reviewed inside the Working Group for Education within a one-month period.
- d) For this purpose, the Secretary of Education will create ad hoc commissions within the working group, whose validity will be maintained during the exercise of the corresponding period of the Secretary.
The commissions will correspond to:
 - 1. North America
 - 2. Central and South America
 - 3. Europe
 - 4. Africa
 - 5. Eurasia Economic Union, Asia and Oceania
- e) Each commission will be integrated by three people, two of them must reside in the respective continents, and one in a different one. They must be members of the working group and participate in teaching at a recognized teaching center. In case there is not the required number of people living in the respective continent for such a commission, persons who do not belong to the working group may be commissioned for that purpose by the Secretary of Education.
- f) The members of the working group who wish to integrate each commission must request it from the Secretary of Education, incorporating their background in teaching into the application. If there are not enough applications to cover the required number, the Secretary of Education may request some person, whether or not a member of the working group and meet the requirements indicated, to integrate the commission.
- g) In this way, the teaching center that requests the accreditation will be evaluated at this stage by the commission ad hocides. For the evaluation of the information sent by the teaching center the commission will examine carefully every teaching program and the examinations of students, and will strictly take into account the academic data provided by the teaching center.
- h) The comission will report to the Secretary of Education and the working group within the stipulated month.
- i) If necessary, the next step will be the consultation process with accredited teaching centers or homeopathic medical associations and the NVP of the same country.
- j) With the intention to guarantee the highest possible level of homeopathic education of each of its members, If necessary or in any case of doubt the Executive Committee reserves to itself the possibility to send a LMHI delegate to the applying teaching center/ homeopathic medical association (to follow the examination process of the applying students), to consult an accredited teaching center or to reject the application. In this case, and if the institution still wants to proceed with the accreditation process, all the costs and expenses will be borne by the applicants.

- k) The LMHI Executive Committee shall make the final decision about the accreditation of a teaching center.
- l) With the intention to guarantee the highest possible level of homeopathic education of each of his members, the Executive Committee of the LMHI will examine carefully every application for accreditation, every teaching program and the examinations of students. If necessary or in any case of doubt the Executive Committee reserves to itself the possibility to send a LMHI delegate to the applying teaching center/ homeopathic medical association (to follow the examination process of the applying students), to consult an accredited teaching center or to reject the application. In this case, and if the institution still wants to proceed with the accreditation process, all the costs and expenses will be borne by the applicants.
- m) All applying teaching centers will be informed about the procedure of the accreditation process and the fact that this process will take a considerable amount of time.
- n) Once the process of accreditation is completed, the LMHI shall issue a certificate confirming that the teaching program, the necessary hours of the homeopathic training, and the examination procedures (written and oral examinations) of this institution have duly been accredited.
- o) The accredited teaching center can advertise itself as a LMHI Accredited Teaching Center and use the LMHI logo in their diplomas.
- p) Graduates from an accredited teaching center can apply for the LMHI Diploma individually or automatically through the teaching center, according to the LMHI Diploma Procedures.
- q) The accreditation remains valid for a period of 6 years and is renewable.
- r) The accreditation fee is valid for the 6-year accreditation period. The fee itself depends on the national situation, as follows:
- independent individual teaching centers €100,00, for the 6-year accreditation period.
 - national federation of teaching centers, €200,00 for the first 2 teaching centers and €50,00 for each additional center.
 - homeopathic doctor association, €200,00.
- s) The accreditation fee is in addition to the membership fee and should be paid once the application is accepted.
- t) Any fees should be paid by bank transfer; checks will not be accepted. Payment should be remitted to LMHI account.
- u) The applicant should notify the Treasurer, the Secretary of Education, the General Secretary and the Secretariat after the payment was successfully done.

- v) Once the payment has been received, the LMHI will issue a diploma certifying the accreditation of the applying teaching center. The shipment costs of the diploma will be afforded by the applicant.
- w) Institutions whose teaching program qualifies for accreditation should pay their annual LMHI membership fee during the years the accreditation is valid. Full member doctor associations that provide training courses themselves pay their normal membership fee in proportion to the number of their members.
- x) Non-payment of membership fee in a particular year will lead to withdrawal of the accreditation.
